## VDOT I64 Expansion Update

On Wednesday, June 27th 2018, VDOT held an open house at Bruton High School to present their designs for the forthcoming I-64 expansion in our area. After the previous open house, in 2017, VDOT told us that they have never seen such a high level of community involvement from any of their other projects. This latest meeting was no exception, with over 150 residents attending, to learn more about the project. Community members that attended received an "I [heart] QL" button to proudly wear. In case you were unable to attend, or just want to study the drawings and documents some more, they can be viewed on-line at <http://i64widening.org/meetings/>. The two primary areas of concern for Queens Lake are storm water management and noise.

For storm water management, VDOT has allocated \$450,000 for "stream restoration" and other storm water repairs in the areas surrounding the headwaters of our lake. This funding is due to a few factors: a budget surplus for the project, our community's pressure and much assistance from Senator Monty Mason. (Please consider sending him a "thank you" email at [district01@senate.virginia.gov](mailto:district01@senate.virginia.gov)) A large component of the restoration involves an area on the other side of the Colonial National Parkway, which we have been calling the "Grand Canyon". This has been a major contributing factor for sedimentation in our lake and we hope the restoration work will curb it. The project will not be using the most modern storm water methods, largely due to issues affecting Camp Peary and Colonial Williamsburg, however this should be a tremendous improvement and probably would not have happened at all if it were not for the efforts of the I-64 committee and the neighborhood at large.

As for highway noise, the locations for the proposed sound barriers can be seen on the drawings on the VDOT site (referenced above). Queens Lake is not slated to receive any sound barriers. Meanwhile, other neighborhoods, like Creekside Landing, will. There are specific Federal Highway Administration criteria for determining whether a sound barrier is "feasible" and "reasonable". Barriers for much of Queens Lake are indeed feasible, however they don't meet the criteria for reasonableness. This comes down to a formula which calculates how many square feet of wall that would be required vs. how many residents would benefit from that wall. Because our lots are rather large and spread out, we don't have enough density to satisfy the formula. On the positive side, they will be paving I-64 with asphalt which should be a good bit quieter than the current concrete. They will also be reconstructing the Queen Creek bridges with a "continuous pour" of concrete, meaning there will not be expansion joints which create the noisy "thump-thump" at every joint. Our committee is continuing efforts to see what can be done about the sound barriers. However, at this point, it appears political and/or legal pressure is about all that we have left. Thank you for your continued support!

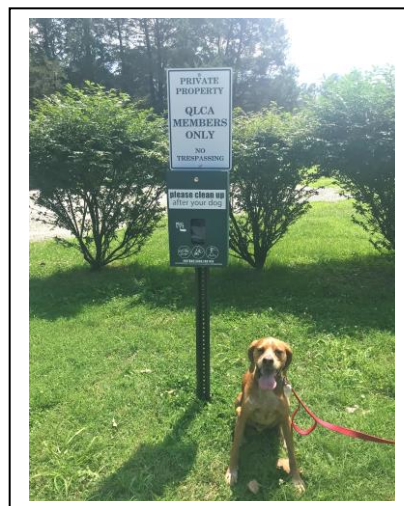
## **Playground**

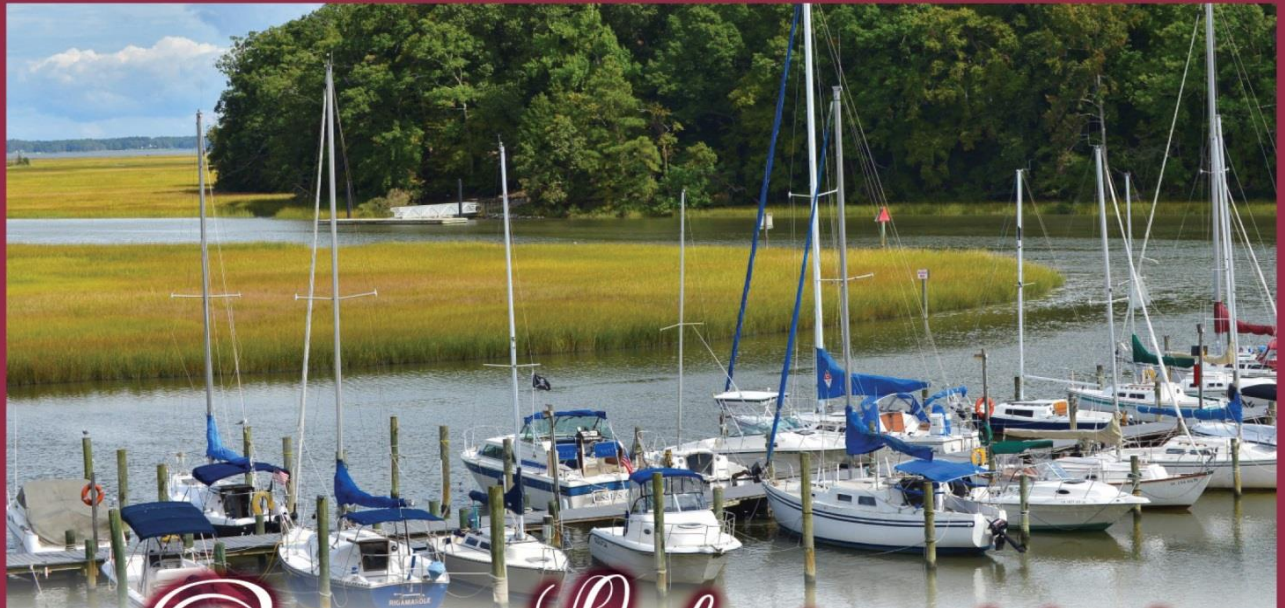

## Kings Court Drainage

In February QLCA was contacted by York County regarding a drainage issue they wished to correct between 263 and 265 Kings Court. QLCA was contacted and included in the county's initial request due to an easement on 263 Kings Court dating back to February 21st, 1961. The County's request was reviewed by our attorney and his opinion was that "Mr. and Mrs. Gibson and Mr. and Mrs. Grafton could grant the requested easement to the County without QLCA being made a party to the Deed of Easement or signing off on it". He also stated that he believes "the County's purpose for including QLCA is to acknowledge that the County's drainage easement may interfere with the pedestrian easement granted to QLCA and to establish that the County's rights are superior to QLCA's". York County's attorney concurred with that assessment. Our attorney further recommended to hold a shareholder vote in accordance with Article IX, Section 9. Following that recommendation the board set a date for a shareholder meeting and notified membership.

QLCA received 56 proxy votes and 3 members attended the meeting on 5/23. That number fell short of the number needed for a quorum. The County was notified the following day that QLCA was unable to reach a quorum. Based on that information, York County decided to remove QLCA from the deed of easement and move forward with the repairs. York County notified QLCA June 13th that the deed between the Gibsons, the Graftons and York County had been filed.

# MARINA

- The marina committee emailed 12 marine contractors the boathouse demo RFP to remove the walls and roof along with the roof support structure. We have received three bids on time as per the deadline we set for: \$185,250 - \$188,437 - \$78,475

By comparison, in early 2017 we received on file, bids from 3 additional contractors in the amounts of \$56,000, \$57,500, \$63,365 and \$70,000. Moreover, three of these bids included the removal of the entire boathouse facility; pilings and decking with only the gas dock to remain intact. Unfortunately all but one of these firms would participate in this latest bidding process. As a side note, the marina committee based our capital reserve request to fund this project on these earlier estimates we were receiving.

The marina committee has chosen Water's Edge Construction (wecmarine.com) to handle this project in the amount of \$78,475. We fully expect to have a contract signed with this firm by late July 2018 with work to start sometime after Labor Day. In the next month or so, the boathouse will be emptied of any valuables. The items belonging to the marina will be moved to the sheds and the marina community will be notified should there be any items they own and want to collect.

- The gas pump isn't currently operational. Phillips Energy has been contacted and we are expecting one of their subcontractors to come today and hopefully repair it.
- We have received 2 bids from Mid-Atlantic Entry System to: 1) to repair the current system for \$1,563.70 or 2) replace the old system with a much simpler one for \$4,244.67. The current system has been described to the marina committee as a "traffic arm" designed to control or regulate the flow of traffic. This machine when operational is easily bypassed and so therefore, doesn't provide security to the marina whatsoever. The marina committee fully intends to investigate other options/firms that will provide the facility with the security the current system fails to do.
- Chris Kolloff with some assistance from Van Dobson and Jeff Otterstein has been looking into upgrading the electrical services on B/C dock. Chris Kolloff will be in attendance tonight to brief the board on his research.
- Easton Outdoors will now be handling the weed control at the marina once per month. They'll also be removing any loose gravel that has accumulated on the tarred roadway/ramp area at that time.
- The Marina Committee's last meeting was on Sunday July 8<sup>th</sup> at the marina.

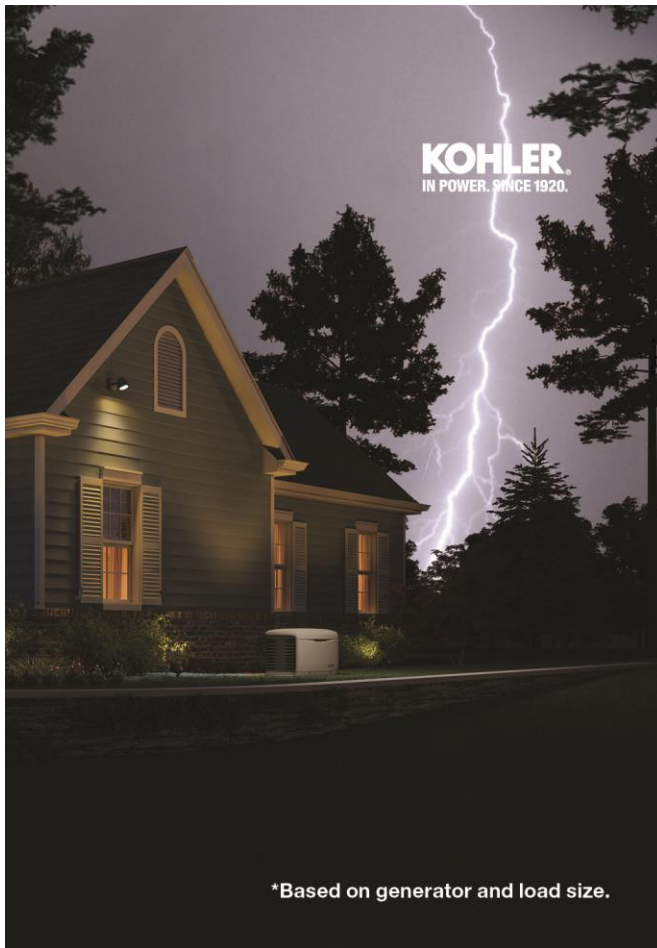

We reviewed the year to date performance vs budget. Two areas of concern are the pool and swim team. Both are projected to be short of budgeted revenue. The pool has a reserve sufficient to cover the short fall although once the shortfall in revenue is covered the reserve account will be depleted.

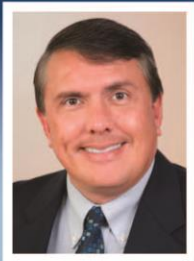
